## DECLARATION

1. 4. I/we accept that the entry remains the property of the History Teachers' Association of Australia (referred to as the 'HTAA') and assign all intellectual property rights in the entry to the HTAA from the date of submission of the entry.
5. I/we consent to any act, omission or thing by the HTAA in relation to the entry that would constitute an infringement of the moral rights of the entrant of attribution and integrity of authorship.
6. The organisation running the Challenge, the HTAA, is required to comply with obligations in the Privacy Act 1988 (Cth). In accordance with the Act, I/we acknowledge that the HTAA will collect certain personal information about the entrant (name and address for example) for the purpose of conducting the Challenge. I/we also acknowledge that the HTAA may disclose that personal information to the Commonwealth of Australia (Department of Education, Employment and Workplace Relations) and the Departments of Education in separate States or Territories of Australia, as well as to the Ministers responsible for those Departments, and any other person from whom the entrant has received a prize. Furthermore, I/we acknowledge that the HTAA, Departments and/or Ministers referred to above may publish certain Personal Information (names and general areas of residence for example) for purposes relating to publicising the Challenge.
